REPORT TO THE RESPONDENT

UPDATE AS TO THE WESTERN AUSTRALIAN STOLEN WAGES SETTLEMENT DISTRIBUTION SCHEME

Pursuant to clause 55 of the Settlement Distribution Scheme

This report is submitted to the State Solicitor's Office ("SSO") in accordance with the requirements set by the Orders of the Court as well as the Settlement Distribution Scheme ("SDS"). The purpose of this report is to provide the SSO with the following information:

- Para 55.1** – The name and date of birth of each Original Eligible Claimant(s);
- Para 55.2** – Whether the Original Eligible Claimant is deceased or alive; and
- Para 55.3** – If deceased, the names and dates of birth of Descendant Eligible Claimant/s that have been determined to be eligible to receive the Original Eligible Claimant payment.

Accordingly, we have prepared the attached schedule which provides the specific data as required above, and make the following comments:

- Para 55.1** – We have provided the details of 534 Original Eligible claimants (total claimants to date are 7,659);
- Para 55.2** – No further comments to the data provided; and
- Para 55.3** – While we have included a list of the Descendant Eligible Claimants, we advise that this list may not be exhaustive as we have not yet completed our review of all applications. Ultimately, the number of Descendant Eligible Claimants is subject to change.

Request for Payment by the State of Western Australia

Given the above we attach an invoice for 534 claimants (the total adjusted for duplicate claims) for an amount of \$8,811,000 which is to be paid to the account nominated on the invoice.
